### **PRESIDENT'S REPORT**

Cheri began her report with the announcement of 81 new LLGA shirts were ordered. The subsidized shirts were \$20 each for your first order and \$35, for your second. A new opportunity to order will be forthcoming. She encouraged all members to sign up for the Golf Genius app and to seek assistance, if necessary, from the Pro Shop. She reminded all members that there is no need to sign up yearly for LLGA UNLESS you are a renter. The league has increased weekly participation/entry fees to \$7, from \$5. She encouraged all members to refer to the LLGA Facebook page, & our webpage for league information. Also, consult the bulletin board in the lady's locker room for additional information.

We currently have 205 LLGA members.

Cheri went on to explain how the Gator Girls point system is awarded. Every Friday, Mary Lane will update the system. Each league member receives 5 points when participating in an event; then appropriate points are assigned when a league member places in an event. The only exception is that no points will be awarded to winners in a scramble. You will only receive 5 points for participating in a scramble. Gator girls this year will be April 16, 2023.
